## RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

- 1. HEREBY AGREE TO RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE** the Parade, or any association, sponsors and /or all Parade participants and the directors, officers, employees, or agents of any of the forgoing, from all liability to me, my personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands on account of injury to person or property or resulting in death, whether caused by negligence or otherwise while observing, working for or participating in the Parade (including, but not limited to, all preparation therefore, the Parade itself, all incidental activities including pre-parade and post-parade activities, and the return of Parade materials to storage locations);
- 2. HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the Releases and each of them from any loss, liability, damage, or costs they may incur due to my presence in any observing, or working for, or participating in the Parade (including, but not limited to, all preparations therefore, the Parade itself, all incidental activities including pre-parade and post parade activities, and the return of Parade materials to storage locations) and whether caused by the negligence of the Releases or otherwise;
